Beyond semantics

Many of Trump's 19-point vision may have mixed bag implications for India.

■ **Curb on trade with China:** Trump wants to regulate the inflow of Chinese goods into American markets. Higher taxes on Chinese goods could be in the offing, as the US would seek to bridge the

trade deficit gap with China. Will the move prove to be an opportunity for India?

■ **Tax reforms:** Trump's promise of rolling back corporate tax rates in the US will mean return of American companies from India.

■ **Immigration policy:** He has hit out against the Mexicans. He wants Americans to be given first preferences

for jobs. This could mean trouble for Indian IT firms.

■ **Economic revival:** Trump will go on a job creation drive for which an economic revival is on the cards. Indians can utilise EB-5 programmes to gain access to the US market. The programme is being used by the Indian businesses to avoid agents and approach the US

customer directly. Indian students also use this to work after studies.

■ **Energy management:** India can gain from stability in the oil market after America's major intervention.

■ **The pharma pitch:** Indian pharma sector had gained a lot under Obamacare. Its reviewed can his the pharma industry in India.

भारत से रणनीतिक संबंध

और प्रमुख रणनीतिक करार दिया था और कहा कूटनीतिक एवं सैन्य गहरा करने को लेकर हैं जो दोनों देशों के हैं। मोदी की आर्थिक नीति की तारीफ कर चुके प्रवसायी ने कहा था कि के प्रधानमंत्री के साथ म करना चाहते हैं। ट्रंप में एक कार्यक्रम में

भारतीय-अमेरिकी समुदाय से वायदा किया था कि उनके रूप में भारत को व्हाइट हाउस में एक सच्चा मित्र मिलेगा। उन्होंने हिंदू रिपब्लिकन कोअलिशन की ओर से आयोजित एक कार्यक्रम में कहा था, 'मैं हिंदुओं और भारत का बड़ा प्रशंसक हूँ। यदि मैं राष्ट्रपति चुना जाता हूँ तो भारतीय और हिंदू समुदाय को व्हाइट हाउस में एक सच्चा मित्र मिलेगा।' ट्रंप ने कहा

था कि वह 'कट्टरपंथी इस्लामी आतंकवाद के खिलाफ लड़ाई में महान मित्र भारत' के साथ हैं। उन्होंने कहा कि भारत ने विगत में 'मुंबई की विभीषिका सहित' 'आतंकवाद की बर्बरता' को झेला है। उन्होंने 2008 में हुए मुंबई हमले और 2001 में भारत की संसद पर हुए हमले को 'अत्यंत घृणित' और भयावह करार दिया था।

ट्रंप डेमोक्रेटिक पार्टी से जुड़ गए और अगले आठ साल यानी 2016-2020 इसका हिस्सा रहे। साल 2008 के राष्ट्रपति चुनाव में उन्होंने रिपब्लिकन उम्मीदवार जॉन मैक्केन के अभियान में बड़े पैमाने पर राजनीति आर्थिक मदद भी की। हालांकि डेमोक्रेटिक पार्टी के उम्मीदवार ओबामा के हाथों मैक्केन को हार झेलनी पड़ी। साल 2009 में आधिकारिक रूप से रिपब्लिकन पार्टी की सदस्यता ग्रहण की। दिसंबर 2011 में एक बार फिर रिपब्लिकन पार्टी से नाता तोड़कर खुद को खुले विचारों वाला घोषित कर दिया। तकरीबन पांच महीने तक ऐसा रहा। इसके बाद अगले साल फिर वह रिपब्लिकन पार्टी में लौट आए। अगले चार साल इन्होंने इस पार्टी के लिए काफी मेहनत की और उन्होंने 2015 में अमेरिकी राष्ट्रपति चुनाव के लिए 2016 में होने वाले चुनावों के लिए पार्टी की उम्मीदवारी भी हासिल कर ली।
