

100 Days Campaign – “Saksham Niveshak”: July 28, 2025 to November 6, 2025

Request to update your KYC details and claim your unpaid/ unclaimed dividends

The Investor Education and Protection Fund Authority (“IEPFA”), Ministry of Corporate Affairs’ Circular has vide its Circular dated July 16, 2025, requested the Companies to launch a **100 days Campaign “Saksham Niveshak”** starting from **“July 28, 2025 till November 6, 2025”** to reach out to the shareholders whose dividend remain unpaid/unclaimed. Accordingly, the Company is rolling out a campaign to enable shareholders to update their details and claim the unpaid /unclaimed dividend.

- ❖ **Purpose of the campaign:** To create awareness among shareholders to update their details and claim any unpaid or unclaimed dividends before they get transferred to the Investor Education and Protection Fund (“IEPF”).
- ❖ **Benefit to shareholders:** It’s important for the shareholders to update PAN; Nomination details, Contact info (postal address, mobile number), Bank account details, Specimen signature with the Company or the Registrar & Transfer Agent, Skyline Financial Services Private Limited (“Skyline”).

Since dividends on shares are payable only through electronic mode for shareholders with unpaid or unclaimed dividends, the amount of dividend will be credited to the shareholder’s bank account only after the required information / documents are updated. Physical shareholders are requested to complete their KYC updates accordingly.
